

VILLAGE OF BRUCE RESOLUTION 19-01A

**FINAL RESOLUTION REGARDING
THE DISCONTINUANCE OF PUBLIC WAYS**

The Village Board of the Village of Bruce, Rusk County, Wisconsin, by this resolution, adopted by a majority of the Village Board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and declares as follows:

The public ways contained in the parcels described below are vacated and discontinued under s. 66.1003 (4), Wis. Stats. It is in the public interest that the public ways described below are vacated and discontinued under s. 66.1003 (4), Wis. Stats. The public ways to be discontinued are located in part of the Plat of Bruce located in the SW ¼ of the NW ¼, and SE ¼ of the NW ¼, of Section 5, T.34 N., R.7 W., Rusk County, Wisconsin, described as follows:

THAT PORTION OF RAILWAY AVE. AS PLATTED, LYING BETWEEN THE EAST RIGHT OF WAY LINE OF 1ST./ STREET A.K.A. 4TH./ STREET ON THE PLAT OF BRUCE AND THE EAST RIGHT OF WAY LINE OF 2ND./ STREET A.K.A. 5TH./ STREET ON THE PLAT OF BRUCE AND THAT PORTION OF 2ND./ STREET A.K.A. 5TH./ STREET ON THE PLAT OF BRUCE, LYING BETWEEN THE NORTH LINE OF RIVER AVE. AND THE SOUTH RIGHT OF WAY LINE OF THE CANADIAN NATIONAL RAIL WAY:

MORE SPECIFICALLY DESCRIBED AS COMMENCING AT THE SOUTHWEST CORNER OF BLOCK 8, ALSO BEING THE POINT OF BEGINNING; THENCE N88°50'19"W ALONG THE NORTH RIGHT OF WAY LINE OF RIVER AVENUE, A DISTANCE OF 66.04 FEET TO THE SOUTHEAST CORNER OF BLOCK 7; THENCE N00°40'29"W ALONG THE EAST LINE OF BLOCK 7 ALSO BEING THE WEST RIGHT OF WAY LINE OF 2ND./ STREET, A DISTANCE OF 30.07 FEET, TO THE NORTHEAST CORNER OF BLOCK 7; THENCE S76°29'59"W, ALONG THE NORTH LINE OF BLOCK 7 ALSO BEING THE SOUTH RIGHT OF WAY LINE OF PLATTED RAILWAY AVENUE, A DISTANCE OF 118.75 FEET, TO THE SOUTH WEST CORNER OF BLOCK 7; THENCE N88°50'19"W ALONG THE NORTH RIGHT OF WAY LINE OF RIVER AVENUE, A DISTANCE OF 144.24 FEET, TO THE EAST RIGHT OF WAY LINE OF 1ST./ STREET; THENCE N00°48'55"W, ALONG THE EAST RIGHT OF WAY LINE OF 1ST./ STREET, A DISTANCE OF 13.83 FEET, TO THE SOUTH RIGHT OF WAY LINE OF THE CANADIAN NATIONAL RAIL WAY; THENCE N76°29'59"E, ALONG THE SOUTH RIGHT OF WAY LINE OF THE CANADIAN NATIONAL RAIL WAY, A DISTANCE OF 334.33 FEET, TO THE EAST LINE 2ND./ STREET; THENCE S00°40'29"E, A DISTANCE OF 98.49 FEET, TO THE POINT OF BEGINNING.


The discontinuance of the above-described public ways will not result in a landlocked property and no owner of property abutting the discontinued public ways will be damaged by the

discontinuance. The discontinued public ways will be vacated and the land awarded to the following owner or owners of real estate abutting the discontinued ways:


